## APRIL 11, 2025 MEETING

COMMISSIONERS PRESENT: Sarah Martin, Kate Gaston, Libbe Madsen (Remote), Vanessa Curl (Remote), Marquez Gibson (Remote), Josie Pady (Remote)

The meeting was called to order at 12:06 pm by JJDPC Chairperson, Sarah Martin.

1. **CALL TO ORDER**

2. **PUBLIC COMMENT FOR ITEMS NOT ON THE AGENDA:** None.
3. **REVIEW AND APPROVAL OF DRAFT MINUTES FROM THE JANUARY 10, 2025 MEETING (ATTACHMENT):** After discussion, the Commissioners approved the January 10, 2025 meeting minutes. Ms. Curl moved to approve; Ms. Martin seconded.
4. **REVIEW AND APPROVAL OF DRAFT MINUTES FROM THE FEBRUARY 14, 2025 MEETING (ATTACHMENT):** After discussion, the Commissioners approved the February 14, 2025 meeting minutes. Ms. Martin moved to approve; Ms. Madsen seconded.
5. **PROBATION REPORT:** No report given.
6. **JUVENILE HALL REPORT:** Mr. Bednar reported there are sixteen youth in the facility: eleven males, and five females. Five of the youth are from Lake County and one is from Del Norte County. They are about ready to move forward on resurfacing the basketball court. They need a few more clearances before they can start. They will need to remove a tree and are looking into areas they can plant a replacement tree. The project will take two to three weeks to complete. They are also moving forward with the improvements in Units A and B. It will take approximately three to four days to complete the work. Staffing is stable. Juvenile Hall is due for the JJDPC inspection. The BSCC inspection is scheduled for August.
7. **DISCUSSION OF DEL NORTE TEEN COURT PROGRAM:** Mr. Bednar reminded the Commissioners that we currently have a Restorative Youth Court paid for out of the JJDPC budget. After discussion, it was agreed that Ms. Martin will reach out to Christina Wilson at the Arbor to ask for additional information on how youth are referred to the program and what is available through the program.

**JUVENILE JUSTICE COORDINATING COUNCIL:** Commissioner Gaston reminded the panel that the commissioners need to nominate someone from the commission to sit on the JJCC. The JJCC meets twice a year. The next meeting is 9/26/25. Katie Ford can provide additional information on the council.
