

# Change an Adult's Name – Mendocino County

These instructions are to get a court order for a name change for an adult (18 or older). But you don't always need a court order. And in some cases, the steps are a little bit different. To figure out exactly what the right steps are for your situation, including gender recognition cases, [answer a few questions online](#).

## Fill out the forms online!!

Use a computer program to help you with all the forms. And you can e-file your forms after if you want.

### FILL OUT COURT FORMS and CHOOSE A NEWSPAPER

- [MNC-110-local](#): *Declaration re: Change of Name*
- [NC-100](#): *Petition for Change of Name*
- [NC-110](#): *Attachment to Petition for Change of Name*
- [NC-120](#): *Order to Show Cause for Change of Name*. Write down the newspaper where you will publish (see information on the back). You can't switch newspapers later.
- [NC-130](#): *Decree Changing Name* (just fill out the top boxes and #3)
- If you cannot afford the fees, ask the court to waive them: [FW-001](#) (fill out completely) and [FW-003](#) (fill out #1, #3, & court & case information, & write name & case number on pages 2 &3)

### START YOUR CASE WITH THE COURT

**Make 1 copy of documents—2 copies of NC-120—and turn them in at:**

**Ukiah courthouse:** room 107, 8:30 a.m. – 3 p.m.

**Fort Bragg courthouse:** clerk's window in the lobby, 8:30 a.m. – 3 p.m.

- The clerk will stamp & return copies & write your court date on the NC-120.
- 1 set of copies is for you.
- The extra copy of the NC-120 is for the newspaper.

### PUBLISH THE NC-120 IN THE NEWSPAPER, 1 per week for 4 weeks in a row

Take your stamped NC-120 to the newspaper. You must complete publication before your court date. The court cannot waive the newspaper's fee.

### GET PROOF OF PUBLICATION FROM THE NEWSPAPER.

Turn it in to the court before your court date.

### GO TO YOUR COURT DATE

If the judge agrees to your name change, the judge will sign the [NC-130: Decree Changing Name](#)

### GET A CERTIFIED COPY OF YOUR DECREE CHANGING NAME

You will need it to change your legal documents, like your birth certificate and driver's license. You will have to make those changes with whatever agency is in charge of the legal document. In California, the [Department of Public Health](#) changes birth certificates; you will need their form [VS-23](#).

## Gender recognition as part of or separate from a name change request

If you're changing your name to match your gender identity, you do not have to publish your name change request in the newspaper, so you can skip that step on page 1.
